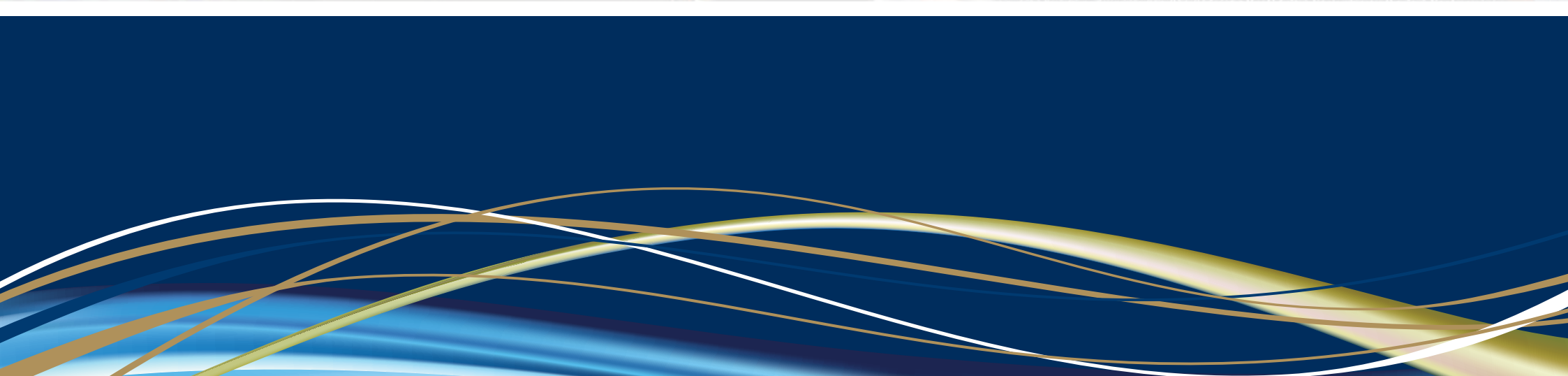

WHAT IS ELEVATE?



Elevate is an exclusive LPM site owner partnership programme established to support the interdependence between Kingdomslots and our LPM Site Partners. The key objective of the programme is to strategically secure and support our partnership by offering a very real share in our joint successes.

- Strengthen our partnership through tangible incentives
- Reward our site owners across all tiers (excluding Type B sites)
- Increased revenue share



HOW DOES IT WORK?

HOW DO YOU QUALIFY?

Site owners with a valid Site Operator Agreement with GGKZN until 31 December 2027 are automatically eligible for the Elevate Incentive Programme. The LPM business must be operational and live on 01 January 2025.

However, to qualify for GGR Year on Year growth and ascending a tier the LPM business must have been operational on 01 January 2024.

HOW DO YOU QUALIFY?

Assessment period 01 January to 31 December 2025.



HOW IS MY SITE'S TIER DETERMINED?

The Tier / status will be the based on the year to date classification as at the end of December 2025, thus giving all sites a year to grow and move up a tier.

CATEGORY A



0.5% of the GGR generated in 2025 will be paid to the site



All Sites EXCEPT sites in the Bronze Tier are eligible for this category



Amount will be determined after December results



The annual payment will be made by 28 February 2026 upon confirmation that Gaming Priority Items are in place

- All Tiers are eligible for this category
- Rand values are awarded for:
 - GGR Year on Year growth (2025 vs 2024 calendar year), site must be live by 1 January 2024,
 - Compliance – Registered Gaming Employee on Duty, Correct Card in the SKP, No under 18s in gaming area, Manual Payout Book completed and no Audit Findings by either KZN Economic Regulatory Authority or our internal compliance officers or auditors in the year
- Rand value will be allocated to Site investment (list of all Gaming priority items to be in place first, thereafter only will the cash be paid)
- Amount will be determined after December results and finalised in January 2026.

- *Tier at end of 2024 vs end of 2025*
- *Site must be live by 1 January 2024*

Site investment will only be paid out to site owner if the minimum key items below are all in place.

Minimum Key Items

Toilets are adequate and in working order

Ring for service' bell in the gaming area / dedicated gaming attendant

Ventilation and aircon in gaming area is adequate

Flooring in the gaming area is in a good condition

Doors, drywalls and Glass of gaming room are intact and in good condition

Television in the gaming area

Extend CCTV to include outside entrance to site

Generator or UPS or Inverter for LPMs
